SCS would evaluate the Tenderer proposal based on the following evaluation criteria:-

- Compliance to Specifications
- **Price:** Just to emphasis that SCS is a volunteer welfare organisation ie. Charity. Therefore we need to keep the cost as minimal as possible.
- **Track Record:** Profile and past experience of company. The vendor should submit past creative and campaigns executed which are relevant for this RFP, the number of people reached and how it helped to achieve outcomes set by the client.
- Creative Concept & Media Plan: Vendor will be evaluated base on the concept and media plan proposed to address the issues and challenges faces. The concept should address the aim to raise awareness for cancer, attend talks and forums and encourage regular screening offered by SCS.
- Any Other Pro Bono/ Value Added Service (Eg: Providing new marketing strategies/ tactics/ helping with creatives for other events that SCS has that are out of the campaigns mentioned)
